- Absentee bids are executed in competition with the audience, on an alternate basis. Due to the uncertainties of bidding patterns, a lot may sell to the audience for the same amount or an amount slightly less than that authorized by an absentee bidder. To avoid this possibility, absentee bidders may authorize us to increase their bid by one increment by placing a plus sign (+) beside their maximum bid. (In the event that identical bids are submitted, the earliest will take precedence.)
- Successful bidders will be notified by email, fax or phone on the day following the auction, Sunday, May 23, 2010. Arrangements will be made at that time to deliver the documents for the items purchased.

BIDDING INCREMENTS: At times, the auctioneer may vary the increments at his discretion.
